The declaration shall be filed in the office of the Regatta Director on or before 18h00 on 31 March 2007. A declaration previously submitted may be amended at any time before 18h00 on 31 March 2007.

A list of sail numbers of declared yachts will be published by the Regatta Director on 1 April 2007 prior to the unveiling.

¹ 13.2 **Declared Yachts:** Three days prior to the scheduled commencement of the first race of the Fleet Race Regatta, Competitors shall declare in writing to the Race Committee the one or two ACC Yachts which they intend to use in the Fleet Race Regatta and the Regatta. A Competitor may declare an ACC Yacht in the course of construction or modification subject to compliance with Article 14.4. Competitors shall only be entitled to use either of those ACC Yachts in the Regatta or the Fleet Race Regatta subject to the substitution or replacement rules of the Notice of Race. Such substitution or replacement rules shall:

- (a) for the Challenger Selection Series, be approved by the Challenger Commission; and
- (b) for the Pre-regattas, Fleet Race Regatta and Match, be approved by the Defender and the Challenger Commission.

The winner of the Challenger Selection Series and the Defender may choose which of their eligible ACC Yachts to sail in the Match, and shall declare it in writing to the Race Committee prior to the Match.
